

Three Forks Flood Mitigation SID Assessment Options

1.0 Background

The City of Three Forks submitted funding applications to FEMA in January 2022 for the purposes of funding a flood mitigation project to reduce flooding risk from the Jefferson River. The proposed mitigation is a grass-lined channel and culvert crossing improvement project that will intercept flood waters west of Three Forks and divert them back to the Jefferson River before reaching the City. The construction cost is estimated at \$5.5 million; the project would reduce flood risk and remove a large portion of the City from the floodplain. The City submitted two applications to FEMA, one under the Building Resilient Infrastructure and Communities (BRIC) grant program and one under the Flood Mitigation Assistance (FMA) grant program.

The City was notified in early August of their selection for further review under the FMA grant program. A selection for further review designation is promising for ultimate award of federal funds, although should not be considered final at this time. If FEMA does not identify any issues in their review, the City can expect award of \$4,152,375 in federal funds to be used for construction of the flood mitigation project, which equates to 75% of the total project cost. The City must provide the remaining 25% or approximately \$1.4 million towards the project.

The City plans to pursue creation of a Special Improvements District (SID) to fund their cost share of the project as well as for costs to maintain the diversion channel post-construction. A SID represents a physical area in which landowners are assessed an additional assessment to fund improvements that benefit the district. The SID creation process involves passing of a resolution of intent which notifies the landowners within the SID. The landowners then have the opportunity to protest and comment during a 30-day comment period. A final resolution is passed after the protest period if the protest hasn't been sufficient to cancel the project.

With notification of selection of further review under the FMA program, the City is ready to begin the SID creation process. In order to draft the resolution of intent for the district, a boundary must be established as well as a defined assessment method. There are several assessment methods that can be used to assess landowners within the district. In the sections that follow, this memorandum describes establishment of the SID boundary and presents assessment options for consideration by the City Council.

2.0 SID Boundary

Exhibit 1 presents the proposed Jefferson River SID boundary as well as the extents of the draft FEMA 100-year floodplain boundary. FEMA is in the process of updating their floodplain maps and if the current condition persists (a flood mitigation project is not constructed), the draft floodplain mapping will be officially adopted for regulatory use in the near future. As shown, almost the entire City limits of Three Forks would fall within the 100-year floodplain and a large part of that area also within the floodway. The increase in flood risk is primarily due to Jefferson River flooding.

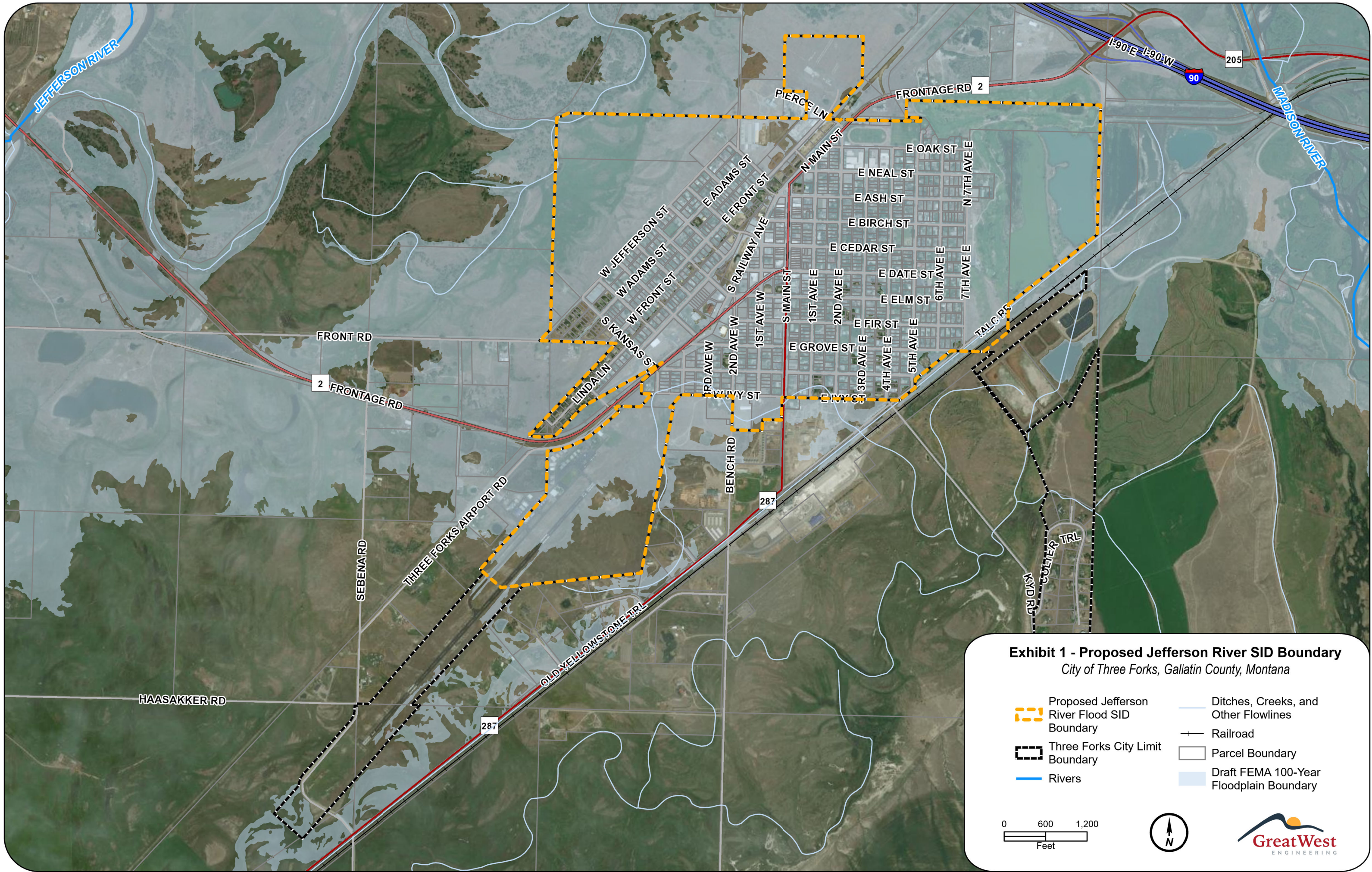
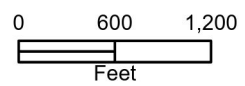


Exhibit 1 - Proposed Jefferson River SID Boundary

The SID boundary was established through inclusion of all the parcels within City limits that would benefit from the flood mitigation project through removal or reduction of the Jefferson River floodplain. Previous analysis has shown the flood mitigation project can remove most of the City from the Jefferson River floodplain, although some areas will still remain within the Jefferson and Madison River floodplains. Therefore, the SID boundary generally coincides with the boundary of the City limits with the exception of the Ridgeview subdivision area to the southeast which is not within the draft floodplain area and part of the City limits to the southwest which does not benefit from the Jefferson River flood mitigation project. The non-benefitting area to the southwest is comprised of airport runway owned by Gallatin County.

There are a few parcels included within the SID boundary that do not currently fall within the draft floodplain mapping. These parcels are still included in the SID due to their proximity to the floodplain boundary. In many cases, the streets bordering the parcel are within the floodplain so these parcels would still be affected through flooding of public infrastructure near the properties.

Additionally, there are a few parcels within the County that will benefit from the project but were not included in the SID boundary. These properties are generally located to the west of the City limits. County properties are not included in the SID due to less complexity in creation of the SID.

3.0 Assessment Methods

Once the SID boundary was established, parcel information for each parcel within the SID was exported into Excel format. Parcel information in Montana is maintained within the Montana Cadastral mapping project database. The SID parcel data was downloaded on September 7, 2022 and used in the assessment methods described below. Detailed parcel data can be found in the parcel tables provided at the end of this memorandum.

There are several options for assessment methods when creating a SID. Two methods were computed and analyzed for the purposes of the Jefferson River SID. Assessment methodology and results are further described below. For each assessment method, it is assumed the City will obtain a 20-year loan through the State Revolving Fund (SRF) program, administered by the DNRC. The total loan amount is assumed to be \$3 million which includes the City's \$1.4 million cost share of the construction project as well as an additional \$1.6 million for easement acquisition that will be required for the project to move forward. Calculations also assume an interest rate of 2.5% over the 20-year loan term. A \$3 million dollar loan is assumed to be the maximum that would be needed. The borrowed amount may be less if the City is able to allocate cash reserves and/or utilize in-kind services for parts of the construction. For the purposes of the resolution of intent, the maximum amount is assumed as it is understood the assessment amount can be reduced after the resolution of intention, but it cannot go up without holding a new 30-day protest period.

3.1 Assessment Method 1A – Per Parcel Assessment

Assessment method 1A represents a per parcel assessment which is the simplest assessment and would simply divide the total loan payment by the number of parcels in the SID to calculate an assessment fee per parcel. There are 993 total parcels within the SID boundary. The total loan payment over the life of the loan is \$3,846,000. This equates to a total assessment of \$3,873.11 per parcel or \$193.66 per parcel per year.

3.2 Assessment Method 1B – Per Parcel Assessment by Parcel Type

Assessment method 1B takes the per parcel assessment one step further and assesses parcels evenly based on parcel type. Cadastral information was initially used to classify parcels as vacant, developed commercial, or developed residential. City staff further refined classifications based on knowledge of actual conditions. Results of this classification are shown on Exhibit 2.

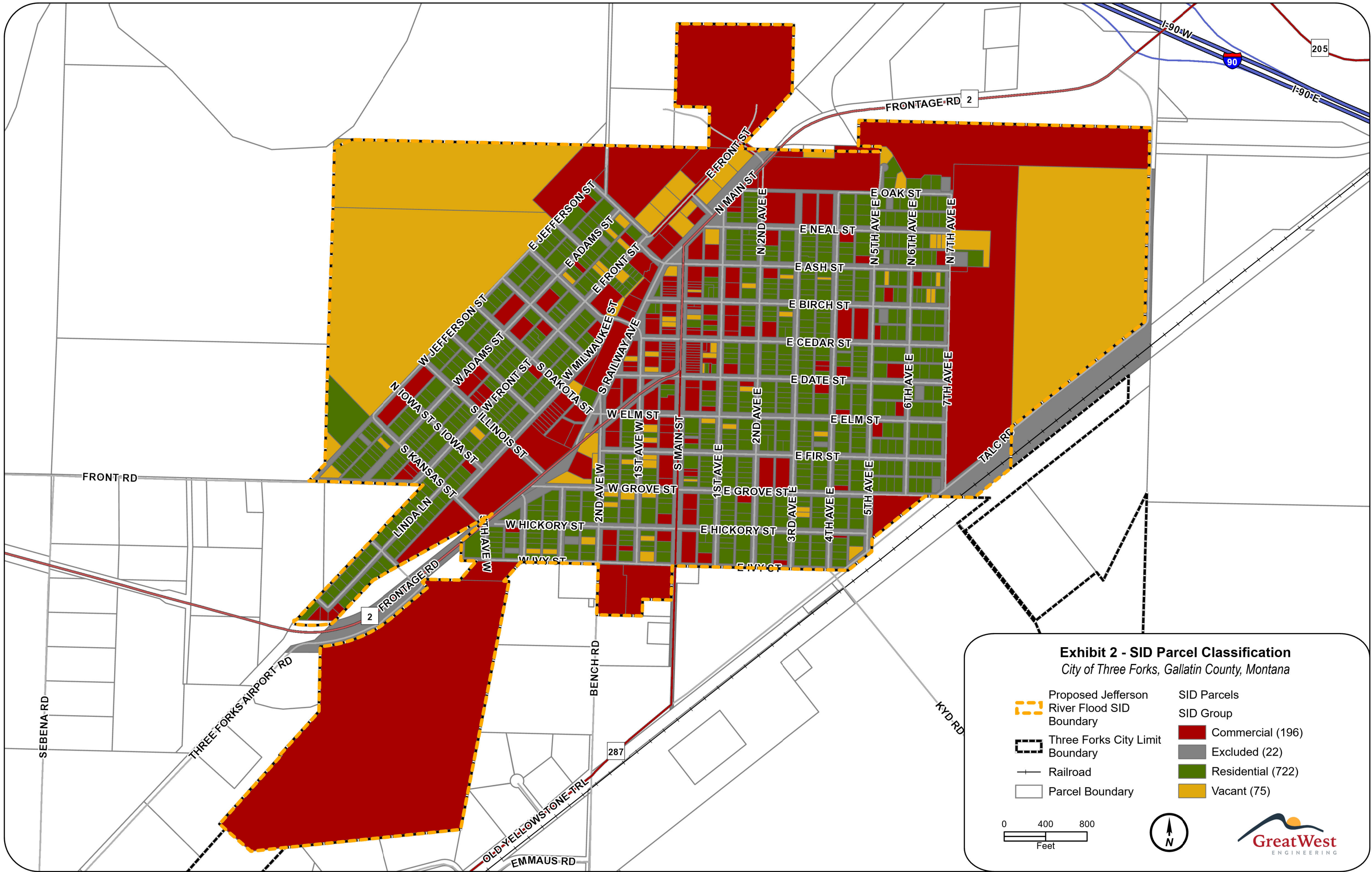










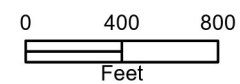


Exhibit 2 - SID Parcel Classification

Parcels classified as “Excluded” as shown on Exhibit 2 generally represent right-of-way properties or properties that do not have any information associated with them. Additionally, City personnel identified several instances where a home or structure crosses the property line of two parcels and the same property owner owns both parcels. In these instances, one of the two parcels was classified as “excluded” and associated property value information from the excluded parcel was added to the included parcel (value assessment is discussed further below).

Assessment 1B assumes that vacant parcels will be assessed \$100 per year per parcel and commercial properties will be assessed \$400 per year per parcel. These initial assumptions result in a calculated residential assessment of \$147.37 per year per parcel. Table 1 summarizes Assessment 1B results.

3.3 Assessment Method 2 – Value Assessment

Assessment method 2 assesses parcels based on the total value of the property. Cadastral maintains this data associated with each parcel. The total value is the sum of the land and building values. The average property value for parcels within the SID is approximately \$225,000. Assessment method 2 assumes all parcels with a property value less than or equal to \$225,000 will be assessed a total assessment of \$3,000 or \$150 per year. Parcels with property values above \$225,000 would be assessed based on the following equation:

$$\text{Total Assessment} = \$3,000 + ((\text{Existing Property Value} - \$225,000) * 0.0190)$$

The equation applies a factor to the property value over \$225,000 and adds that to the \$3,000 flat fee. The factor was determined using Excel’s solver solution so the sum of the total assessment for all properties equates to the total loan payment of \$3,846,000. Detailed parcel data spreadsheets are attached at the end of this memorandum. Data is sorted in descending order by total assessment value using assessment method 2. The highest assessed parcel using this method results in a total assessment of \$25,616 or \$1,281 per year for that parcel.

3.4 Assessment Method Comparison

There is no “perfect” solution in development of assessment methodologies for the SID. The flood mitigation project will ultimately provide benefit to the entire community of Three Forks. The goal of the SID assessment is to provide the most fair and equitable approach to the largest extent possible. There are pros and cons associated with both methods provided above. For example, vacant parcels that may soon develop may be perceived to receive a “break” under assessment method 1B as they will be locked in at the vacant rate. Although simplistic, a flat fee per parcel is generally the most commonly used structure assessment based on knowledge of existing SIDs in Montana. Taxable value structures may have the potential to result in legal implications.

4.0 Maintenance

SID properties will also be assessed an annual maintenance fee that can be expected to cost roughly \$20 to \$50 per year per parcel. Maintenance will be required on the channel for routine mowing and weed control to assure the channel maintains the required capacity for flood protection. Great West Engineering will be putting together a maintenance plan that documents the need for these charges and finalizes costs. The maintenance fee will remain in place even after the 20-year loan is paid off.
